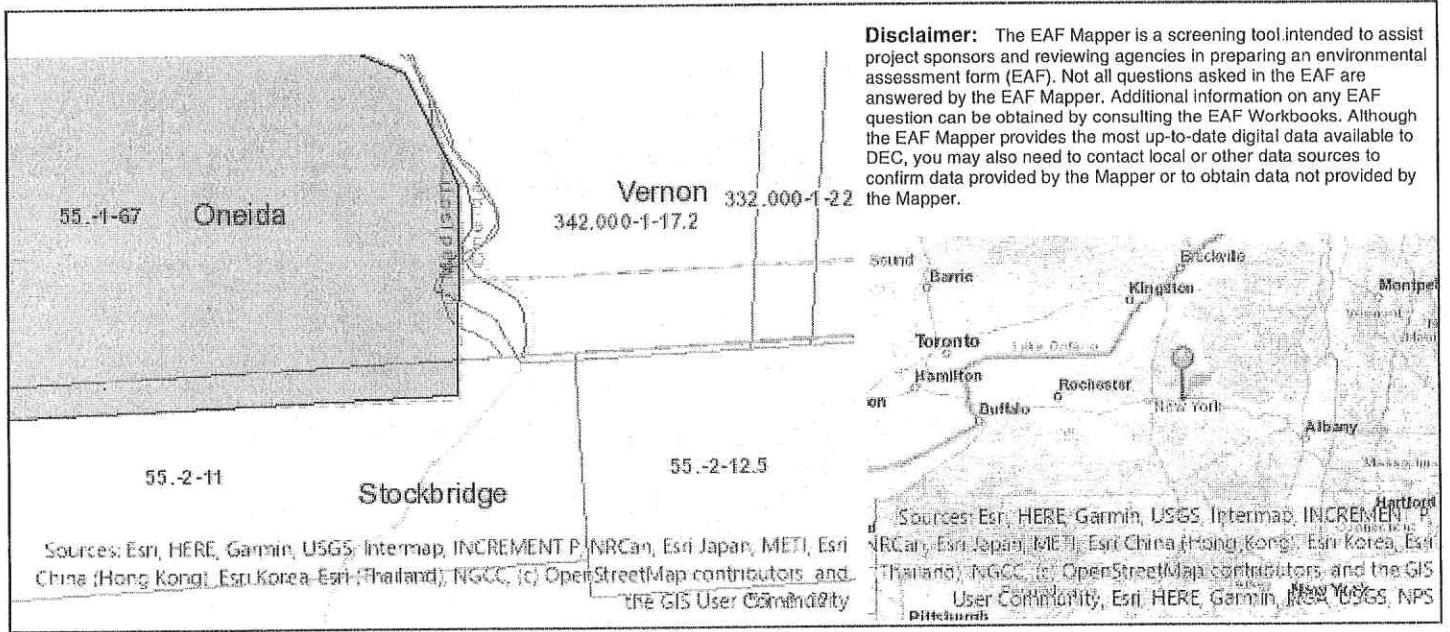

The proposed action is the adoption of a local law amending Chapter 190 (Zoning) of the Code of the City of Oneida to establish standards governing wireless communication facilities and large-scale telecommunications towers. The action is legislative in nature and does not approve or authorize construction, grading, excavation, or disturbance of any specific site. The amendment does not expand the districts in which wireless communication facilities are permitted and does not rezone or alter district boundaries. Rather, it refines and strengthens regulatory standards for an already conditionally permitted use as reflected in the City's Schedule of Uses. Because the proposed action does not result in physical alteration of land, does not increase development density, and does not change land use patterns, it will not result in significant adverse impacts to land, water, air, agricultural resources, historic resources, transportation, community character, or other environmental factors. Any future telecommunications tower application will be subject to site-specific environmental review under SEQR and compliance with all applicable federal, state, and local regulations. Based on the information provided in Part 1, the impact analysis in Part 2, and the legislative nature of the action, the City concludes that adoption of this amendment will not result in any significant adverse environmental impacts.

**Determination of Significance - Type 1 and Unlisted Actions**
